This year you can get your money **as early as Thursday, January 2nd, 2025**, which is **before the IRS opens!** To get the advance we need to be able to submit your complete return (which means we must have all your W2s, self-employment data, and the 1095-A form if you got insurance through the HealthCare "Marketplace").

The Child Tax Credit and the Daycare Credit are the same as last year, but the Earned Income Tax Credit has increased by 8%.

If you want to apply for one of these advances or if you just want your return prepared early to get your refund as soon as possible...

Even if you don't have your W-2's yet, we can use your pay stubs to find out what your refund should be. We will begin our appointments on Thursday, January 2nd, 2025.

- Earned Income Credit **maximum** (depending on your income):
 - No qualifying children: \$649
 - One qualifying child: \$4,328
 - Two qualifying children: \$7,152
 - Three qualifying children: \$8,046
- **Increased** standard deductions:
 - Head of Household: \$21,900
 - Married Filing Joint: \$29,200
 - Single: \$14,600

Goodies from last year still in effect this year...

- **\$500 "Non-Child Dependent Credit"** for children who are too old for the Child Tax Credit. Also for claiming parents or other household members.
- **Qualified Business Income** deduction for self-employed folks.
- Electric Vehicle Credit up to \$7,500 for qualifying vehicles
- **Expanded** Residential Energy Credits

Still available this year with appropriate income...

- Education Credits (we must have your 1098-T statement from college and book/supply receipts)
- Retirement Savings Credit
